


1. According to the Government letter No. गुनिमं/2017/272/प्र.क्र.98/निवसं-2 dated on 23/03/2022, testing charges for construction material are waived for all irrigation corporations working under WRD, Maharashtra.
2. Additional transport charges for all the field tests whenever incurred shall be paid by the party requiring tests to be carried out including WRD, Maharashtra.
3. Regarding Field tests all the charges are excluding those for transportation, mazdoors required on field and field assistance.
4. As per Govt. Letter No EIR-1083/300(332) PT. Dated 23/8/1984, rates for Private Bodies, Semi- Govt. and Other state Govt. will be charged double.
5. GST will be levied extra as per Govt. rules on the total bill for Private bodies, Semi Govt. and other State Govt. etc.
6. Charges for auguring/ boring to have added whenever incurred.
7. The testing charges are to be paid promptly at the time of sample deposition against issue of the invoice. Failing of which, the storage charges for the soil samples at the rate of 1 % per month on the invoice amount will be applicable for the delayed period.
